ORDER:

In the G.O. 7th read above, Government have issued certain fiscal incentives/benefits to SC & ST Entrepreneurs, among others under Industrial Development Policy, 2015-20.

2. Government, after careful examination of the references read above, hereby approves the introduction of "**Entrepreneurship Development Programme and Skill Development Programme Scheme**" for benefit of SC/ST Entrepreneurs in the State of Andhra Pradesh.

Introduction

Government of Andhra Pradesh proposes to introduce the following training programmes **free of cost** to SC/ST Entrepreneurs under the above scheme.

1. Residential Entrepreneurship Development programme - 2 weeks
2. Skill Development Programmes - 2 months to 3 months

These development programmes shall be held at reputed institutions of excellence such as IGIAT, NI-MSME, CIPET, CFTRI, CLRI, CITD, DICCI etc. Training shall be imparted across a wide spectrum of manufacturing and service related vocations.

Eligibility

1. Domicile of Andhra Pradesh in the age group 18-50 years
2. SC/ST caste certificate issued by Government of Andhra Pradesh
3. Minimum qualification/class - X Pass

Identification

Applications can be submitted on a white paper with contact details of the entrepreneur at the local District Industries Centre Office.

The following Task Force shall meet once in a month to select eligible entrepreneurs from the list of applications received on the basis of interview:
