

## Grant & Renewal of Wholesale Drug Licenses in form 20B & 21B

### Step 1:

Submit following document at Office of Drug Controller-Chandigarh, Sector 34, Chandigarh.

- Application Form 19 each for Non Biological and Biological drugs.
- Rs. 1500/- for each license (total 3000/-) to be in the form of Bank Draft issued in favour of PMO, UT, Chandigarh
- Site Plan of proposed premises in triplicate with location plan.
- Proof regarding possession of premises e.g. documents regarding premises ownership or rental or other basis.
- Certificate of education qualification of applications/partners.
- Certificate of education qualification and experience certificate of competent Person i.e. Matric with 4 years experience in the sales of Drugs or graduate with 1 year experience in dealing with drugs or Registered Pharmacist with Chandigarh Pharmacy Council.
- Self declaration or Affidavit of Proprietor, Partners, Authorised Signatory, and Directors as the case may be.
- Self declaration or Affidavit of Technical Person (competent Person).
- Copy of purchase bill or other proof of Refrigerator/Air conditioner for the premises.
- Residential and identity proof of Proprietor/Partners/Authorised Signatory/Directors and Qualified Person.
- In case of Pvt. Ltd. & Ltd. company:-
  - a) List of Directors with address.
  - b) Copy of Resolution of board of Directors.
  - c) Memorandum of Article.
  - d) Form 32 regarding status of Directors.
  - e) In case of Partnership concern, copy of partnership deed.

- Power of Attorney, if the application through Attorney Holder
- Dissolution Deed/the sale deed in case of transfer of business.
- Previous Drugs Licenses in cases of application for grant of license due to change of Constitution or transfer of business or change of Premises.

Note: All documents shall be in duplicate. All photocopies shall be attested by Gazetted Officer/ Notary.

- Site visit by Concerned Inspector.

**Step 5:**

- Forwards recommendations to Director Health Services-cum-Drug Controller for allotment of registration.

## Grant & Renewal of Homeopathic Licenses in form 20B & 21B

### Step 1:

Submit following document at Office of Drug Controller-Chandigarh, Sector 34, Chandigarh.

- Application Form 19 -B.
- Receipt Challan Rs. 250/- to be deposited in Bank in favour of PMO, UT, Chandigarh
- Site Plan of proposed premises in triplicate with location plan.
- Proof regarding possession of premises e.g. documents regarding premises ownership or rental or other basis.
- Certificate of education qualification of applications/partners.
- Certificate of education qualification and adequate experience certificate of competent Person or Registered homeopathic Certificate.
- Self declaration or Affidavit of Proprietor, Partners, Authorised Signatory, and Directors as the case may be.
- Self declaration or Affidavit of Technical Person (competent Person).
- Residential and identity proof of Proprietor/Partners/Authorised Signatory/Directors and Qualified Person.
- In case of Pvt. Ltd. & Ltd. company:-
  - a) List of Directors with address.
  - b) Copy of Resolution of board of Directors.
  - c) Memorandum of Article.
  - d) Form 32 regarding status of Directors.
  - e) In case of Partnership concern, copy of partnership deed.

- Power of Attorney, if the application through Attorney Holder
- Dissolution Deed/the sale deed in case of transfer of business.
- Previous Drugs Licenses in cases of application for grant of license due to change of Constitution or transfer of business or change of Premises.
- Other requirements as per conditions under rule 67-F for grant of licenses under Drugs & cosmetics Rules, 1945.
