# Part I – Law(s) Governing the eForm

Section and Rule Number(s) eForm MGT-6 is required to be filed pursuant to section 89(6) of the Companies Act, 2013 which is reproduced for your reference.

### **Section 89(6):**

Where any declaration under this section is made to a company, the company shall make a note of such declaration in the register concerned and shall file, within thirty days from the date of receipt of declaration by it, a return in the prescribed form with the Registrar in respect of such declaration with such fees or additional fees as may be prescribed, within the time specified under section 403.

### Purpose of the eForm

A company makes a declaration to the Registrar regarding persons whose name is in the register of members as a shareholder but they do not hold any beneficial interest in such shares. This form of return is filed within 30 days of receipt of declaration by the company by filing eForm MGT-6.

## Part II – Instructions to fill the eForm

## Specific Instructions to fill the eForm MGT-6 at Field Level

Instructions to fill the eForm are tabulated below at field level. Only important fields that require detailed instructions to be filled in eForm are explained. Self-explanatory fields are not discussed.

S. No/ Section	Name	Field Name	Instructions
1	(a)	Corporate ident of number (CIN) compan	Enter the Corporate identity number (CIN) of the company.  You may find CIN by entering existing registration number or name of the company in the 'Find CIN' service under the menu MCA services on the MCA website.
2	(a) & (b)	Pre-fill button	Click the <b>Pre-fill</b> button. On clicking the button, system shall automatically display the name and registered office address of the company.
I to VI		Particulars of shares in respect of which the person whose name is entered in the register of members of the company as a holder of shares does not hold the beneficial interest in such shares	It is mandatory to enter details regarding the beneficial interest and the registered and beneficial holder of such shares in Section I. Section II to VI are optional.
To be signed	-	Declaration	Enter the date of board resolution where signatory has been authorized to sign and submit the eForm.

	DSC	Ensure the eForm is digitally signed by the Director, Manager, CEO, CFO or Company Secretary of the company. In case the form is signed by a director, DIN shall be entered.  In case the form is signed by a manager/CEO/CFO, PAN or DIN shall be entered.  In case the form is signed by a Company Secretary,  Membership number shall be entered in case of other than Section 8 company.  In case of Section 8 company and if designation selected as 'Company Secretary', either membership number/PAN shall be entered.
Attachments	<ul> <li>Declaration by person referred to in section 89(1)</li> <li>Declaration by person referred to in section 89(2) or 89(3)</li> <li>Any other information can be provided as an optional attachment(s).</li> </ul>	

## Common Instructions to fill eForm

Buttons	Particulars
Pre-fill Pre-fill	The <b>Pre-fill</b> button can appear more than once in an eForm. The button appears next to a field that can be automatically filled using the MCA database.

Remove Attachment	You can view the attachments added to the eForm in the List of

	To remove any attachment from the eForm, select the attachment in the <b>List of attachment</b> field and click the <b>Remove attachment</b> button.

On successful validations, a message is displayed "Form level pre scrutiny is successful". Note: The Check Form functionality does not require Internet connectivity.</li> </ol>		
Modify Modify	The Modify button is enabled, after you have checked the eForm using the <b>Check Form</b> button.  To make changes to the filled and checked form:  1. Click the <b>Modify</b> button.  2. Make the changes to the filled eForm.  3. Click the <b>Check Form</b> button to check the eForm again.

If there are no errors, a message is displayed "No errors found."</li> </ol> The <b>Prescrutiny</b> functionality requires Internet Connectivity.

## **Processing Type**

The eForm will be auto approved under straight through processing(STP) mode.

### **SRN** Generation

On successful submission of the eForm MGT-6, SRN will be generated and shown to the user which will be used for future correspondence with MCA.

### Challan Generation

On successful submission of the eForm MGT-6, Challan will be generated depicting the details of the fees paid by the user to the Ministry. It is the acknowledgement to the user that the eForm has been filed.

### Email

When an eForm is processed by the authority concerned, an acknowledgement of the same is sent to the user in the form of an email to the email id of the company.

# Fee for filing Form MGT-6 (in case of company having share capital)

Nominal Share Capital	Fee applicable
Less than 1,00,000	Rupees 200
1,00,000 to 4,99,999	Rupees 300
5,00,000 to 24,99,999	Rupees 400
25,00,000 to 99,99,999	Rupees 500
1,00,00,000 or more	Rupees 600

Fee for filing Form MGT-6 (in case of company not having share capital)  $Rupees\ 200$ 

### **Additional fee**

Period of delays	Fee applicable
Up to 30 days	2 times of normal fees

More than 30 days and up to 60 days	4 times of normal fees
More than 60 days and up to 90 days	6 times of normal fees
More than 90 days and up to 180 days	10 times of normal fees
More than 180 days	12 times of normal fees

In case of an IFSC company, the additional fee shall be applicable only after the expiry of 60 days from the date of receipt of declaration.

However, in case of form filing after 60 days, the logic for delay days' calculation for computing the additional fee shall remain same as in case of other than IFSC company i.e. due date shall be considered as (Event Date + 30) even for an IFSC company.
