RESOLUTION

The 1st September, 2014

JHARKHAND INDUSTRIAL INCENTIVE OPERATIONILISATION PROCEDURE'

No.-2543--In exercise of the powers conferred under clause 37.4 of the Jharkhand Industrial Policy- 2012 (JIP-2012), the INDUSTRIAL INCENTIVE GUIDELINES/PROCEDURE is framed by Industry Department for smooth operation of various incentives/concessions admissible to industries under the JIP-2012.

- 1. Name of the Procedure: These incentive rules shall be known as JHARKHAND INDUSTRIAL INCENTIVE OPERATIONILISATION PROCEDURE'.
- 2. Definitions:
- **2.1. Effective date:** "Effective date" means the date on which the provisions of this Policy came into force i.e. 01.04.2011 and will remain in force for 5 years i.e. up to 31.03.2016.
- **2.2. Government:** The word Government wherever used shall mean and include the Department of Industries, Government of Jharkhand.

Wherever the word Central Government has been used, it shall mean Government of India.

- **2.3.** "Existing Industrial Unit" means an industrial unit which is in commercial production on or before 31.03.2011.
- **2.4. Industrial Unit/Industrial Concerns**: as defined under clause 2 of Annexure-I of JIP- 2012, read with Annexure-II.

2.5. New Industrial Unit

- (i). "New Industrial Unit" means an industrial unit in which commercial production has commenced within five years from 01.04.2011 and Date of Production Certificate (DOP) has been issued under clause 35 of JIP-2012
- (ii) A Power Plant generating power from renewable sources, with commercial operation after the effective date of implementation of JIP-2012, shall be deemed to be a new industrial unit and will be entitled to all the incentives under JIP-2012. These plants will not be liable to pay 50% electricity duty for a period of 10 years.

2.6. Expansion / Modernization

"Expansion / Modernization of an existing unit would mean additional fixed capital investment to the extent of 50% or more of the non-depreciated value of fixed capital investment just before taking up this expansion / modernization in this unit leading to at least 70% of additional production of the capacity along with 70% of the total created capacity after expansion.

Illustration

Expansion/Modernisation: If non-depreciated fixed capital investment in a unit before Expansion/Modernization is Rs. 100.00 cr. and its yearly capacity of production is 1000T and if the unit invests Rs. 50.00 cr. or more as fixed capital investment and the capacity after Expansion/Modernization is raised by additional 700T i.e. total capacity after Expansion/Modernization is 1700T and minimum production achieved from the unit after Expansion/Modernization is 1190T (i.e. 70% of total capacity of 1700T) then a unit is considered to have under gone Expansion/Modernization.

2.7. Diversification

- i. Diversification of an existing unit would mean additional fixed capital investment to the extent of 50% or more of the non-depreciated value of fixed capital investment just before taking up this diversification in this unit leading to increase in turnover by 50%, over the highest turnover achieved during past three years immediately before taking up this diversification.
- Diversification must result in production of at least one additional product. If the unit discontinues with the existing production, the increase in turnover will not be considered.

Note: The eligible unit claiming benefits under expansion/modernization/ diversification shall be required to maintain separate record of production for such expansion/ modernization/diversification. In case, maintaining a separate record is not possible by such units the benefit to such eligible units shall be available in the ration of installed capacity.

Illustration

Diversification: If non-depreciated fixed capital investment in a unit before diversification is Rs. 100.00 cr. and its Highest Turnover achieved during last three years before taking up diversification is Rs. 20.00 lakh and if the unit invests Rs. 50.00 cr. or more as Fixed Capital investment for diversification and Turnover achieved after diversification is minimum Rs. 30.00 lakh (i.e. 50% more than earlier turnover) and atleast one additional product is added to product mix then unit is considered to have been diversified. If the unit discontinues with the existing production, the increase in Turnover will not be a consideration for declaring the diversification of the unit.

2.8. Fixed Capital Investment

The 'Fixed capital investment' means an investment made in land, building, plant and machinery as well as productive assets of permanent nature such as tools, jigs, fixtures, dies, crane, electrification except DG Set and pollution control equipment.

2.9. Date of Production

- (a) The "Date of Production" of an industrial unit shall mean the date on which the unit actually commences commercial production of the item for which the unit has been registered, in terms of clause 35.2 of JIP-2012.
- (b) For the Date of Production (DoP) of a Micro and Small Units/Enterprise (MSE) the certificate issued by the respective General Manager, District Industries Centre or the respective Managing Director, Industrial Area Development Authority would be valid.
- (c) In case of any dispute regarding the Date of Production (DoP) of Micro and Small Unit, issued by IADA's / GM, DIC, the decision of the Director of Industries shall be final.
- (d) In case of Industries other than MSE, as described in 'b & c' above, the certificate issued by the Director of Industries would be valid.
- (e) In case of any dispute regarding the Date of Production (DoP) of large and medium industries, issued by Director of Industries, the decision of the Principal Secretary /Secretary, Industries shall be final.
- (f) Classification of Industrial Units: As defined under clause 11 of Annexure-I of JIP-2012.
- (g) Classification of Backward Areas: As defined under clause 12 of Annexure-I of JIP-2012.
- (h) Renewable energy: As defined and explained by Ministry of Renewable Energy, Government of India from time to time.
- (i) A format for Date of Production certificate by Directorate of Industries/IADAs/DICs and application to be filled up and submitted by industrial unit claiming incentives/ subsidies under JIP-2012 is given in Form-2A, 2B, 2C, 2D & 2E.
- **2.10. Financial year for Incentive purpose:** Industrial Units will be entitled for re-imbursement/payment of subsidy/incentive under different categories only from the next financial year of the date of DoP as provided in para-35.7 (b) of JIP-2012. Financial year means year starting from 1st April of the year to 31st March of the next year.

After examination of application and at the time of sanction of incentive an unit has to submit detailed information in format-1.4 to verify average production level of at least six months.

- **2.11. Mega Projects**: Sector wise classification of Mega Projects has been provided in clause 11 (iii) of Annexure-I of JIP-2012. Other industrial sectors with investment above Rs.250 crore and not specified in the said schedule, will come under Mega Project category.
- **2.12. Project report**: Means the Detailed Project Report (DPR)/TFR, duly approved by the Financing Banks/Financial Institutions and, in case of self financed units, DPR duly certified by Chartered Accountants.
- **2.13** All eligible units under-JIP-2012 may submit applications separately for different types of incentives for each financial year in the prescribed formats for financial years starting from 1st April 2011.
- 3. Comprehensive Project Investment Subsidy (CPIS)
- **3.1.** Eligibility -Industrial Units, other than those under Mega category shall be entitled to get Comprehensive Project Investment Subsidy (CPIS) for investment made in :
 - (i) **Plant and Machinery**: Investment in Plant & Machinery means aggregate of price paid to Suppliers excluding taxes like Central excise /VAT/CST.

The plant and machinery shall be new (excluding imported machinery) for which affidavit in prescribed format needs to be submitted. The amount of investment will include import duty (excluding miscellaneous expenses as transportation from the port to the site of the factory, demurrage paid at the port), shipping charges, customs and clearance charges.

- (ii) **Pollution Control Equipment (PCE)**: Investment in PCE means aggregate of price paid to Suppliers excluding taxes like Central excise/VAT/CST.
- (iii) **Environment friendly alternative power generation equipment**: Means environment friendly D.G. set other than normal DG sets.
- (iv) Payment for Employee Welfare (EPF, ESI, and Health Insurance Scheme): Actual contribution made by the employer after DOP towards employee welfare will form the basis of calculating, on pro-rata basis, the total amount for 10% weightage benefit under CPIS for five years. The amount contributed will also be the basis of incentive in the first year. Payment of admissible incentive in subsequent years will be made based on the actual contribution during the year subject to a maximum ceiling of 20% of the total amount calculated as 10% weightage. The necessary correction, if any will be done in the concluding year of incentive payment.

(v) The qualifying amount of investment for subsidy under CPIS will be calculated giving weightage of 50% to investment made in Plant and Machinery, 20% each to investments in pollution control equipment and environment friendly alternative power generation equipment and 10% to investment in employee welfare (EPF, ESI, Health Insurance).

3.2. Scope of Incentive

3.2.1 Additional incentive of 5% for SC/ST/Women/Handicapped Entrepreneurs under CPIS (as per clause- 32.1.7 of JIP-2012) on production of:

- i. Caste & residential certificate by the competent authority not below the rank of SDO in the State of Jharkhand.
- ii. For handicapped category, certificate of a competent Medical Board under the chairmanship of Civil Surgeon to have handicap of more than 40%.

3.2.2. Special Incentive for extremist infested blocks

Non-mineral based (industries not using the mineral resources of the State) new industrial units located in the **extremist infested blocks** (5 Kms beyond municipal boundary) with minimum investment of Rs. 5 crore in plant and machinery and providing direct employment to

minimum 100 persons shall be eligible **for additional incentive of 5% under CPIS**. (Clause 32.1.8 of JIP-2012)

3.2.3. The policy envisages direct employment of specified number of work force for some industries to avail certain facilities / incentives etc. of the government. **Industries implementing State Government Reservation Policy in such direct employment will be eligible for 5% additional incentive under CPIS.** (Clause 32.1.9 of JIP 2012)

Illustration

- (a) Suppose CPIS calculated for a unit is Rs. 2.00 cr. If the unit is owned by SC/ST/Women/Handicapped Entrepreneur, then payment of CPIS will be Rs. 2.10 cr. i.e. 5% additional amount over calculated CPIS of Rs. 2.00 cr.
- (b) It the unit is located in the extremist infested block and CPIS calculated is Rs. 2.00 cr. then payment of CPIS will be Rs. 2.10 cr. i.e. 5% additional amount over calculated CPIS of Rs. 2.00 cr.
- (c) If the unit implements State Govt. Reservation Policy in such direct employment and the calculated CPI is arrived at Rs. 2.00 cr., then also the payment of CPIS for such unit will be Rs. 2.10 cr.

If the unit is owned by SC/ST/Women/Handicapped entrepreneur, located in extremist infested area and implements State Govt.'s reservation policy in such direct employment, then CPIS payment for the unit will be Rs. 2.30 cr. (0.1 cr. on account of each clause 3.2.1, 3.2.2 and 3.2.3).

However, payment of incentives under CPIS including additional payment under different provisions will not exceed the ceiling limit of Rs. 5.00 cr.

- **3.2.4.** Industrial Units entitled for benefits in the CPIS categories {S1. 32.1.1 (i to iv) of JIP-2012} under Govt. of India Scheme will not be eligible to get benefits under the category under these rules.
- **3.2.5.** Maximum admissible subsidy under CPIS for an industrial unit will be Rs 5 crore.
- **3.2.6.** Industries availing subsidy under CPIS will not be eligible to avail benefits available in sl. 32.2 of JIP-2012 (stamp duty and registration fee)

3.3. Procedure under CPIS

3.3.1. For New Unit

Application in **Form - 1** has to be submitted with all the enclosures to respective MD, IADA's /GM, DIC along with the prescribed documents:

Respective MD, IADA's /GM, DIC will scrutinize the application, received by them as per check list and, after site inspection of the unit, will forward the same to Directorate of Industry, Jharkhand, Ranchi within 3 weeks of receipt of application.

3.3.2. For Expansion/Modernization/Diversification of industrial units.

Application in **Form - 1** along with **Form-A** has to be submitted with all the enclosures to respective MD, IADA's /GM, DIC along with the prescribed documents for claiming benefit in respective of incremental production/diversified product resulting out of Expansion/Modernization/Diversification.

Respective MD, IADA's /GM, DIC will scrutinize the application, received by them as per check list and, after site inspection of the unit, will forward the same to Directorate of Industry, Jharkhand, Ranchi within 3 weeks of receipt of application.

- **3.3.3** Claims under CPIS for 2nd to 5th year can be made using **Form-1.9** only.
- **3.4**. Only one time subsidy under CPIS category will be provided to the industries. The subsidy payment will be spread over a period of 5 years time @ 20% of payable amount of subsidy payment in each year.

4. Incentive for reimbursement of Stamp duty & Registration Fee

- **4.1.** Manufacturing units with direct employment of 100 persons will enjoy 50% reimbursement of stamp duty and registration fee for land directly purchased from the raiyats/acquired through consent award. This facility will be granted only for the first transaction for a particular plot of land (clause 32.2.1 of JIP-2012).
- **4.2.** 100% reimbursement of Stamp Duty and Registration Fee for land will be allowed for industries offering 100 direct employment per acre of land bought (clause 32.2.2 of JIP-2012).
- **4.3.** Following Industries are not eligible for such benefit:
 - i) Industries which have availed incentive under CPIS.
 - ii) Lessee of IADA/Industrial Parks.

iii) Industries engaged in mineral extraction activities such as mining, crushing, transportation, washing etc. without significant value addition.

4.4. Procedure

Application in **Form - 1** along with **Form-B** has to be submitted with all the enclosures to respective MD, IADA's /GM, DIC along with the prescribed documents:

Respective MD, IADA's /GM, DIC will scrutinize the application, received by them as per check list and, after site inspection of the unit, will forward the same to Directorate of Industry, Jharkhand, Ranchi within 3 weeks of receipt of application.

5. Incentive for Quality Certification

5.1. Eligibility

- **5.1.1.** Industries obtaining Quality Certification from B.I.S. and other internationally recognized institutions, as listed under clause 32.3 of the JIP 2012, will be given assistance of 50% of the expenditure incurred to obtain said certification up to maximum of Rs.2.0 lakh.
- **5.1.2.** An Enterprise can avail the facility for more than one certification during the policy period subject to maximum limit of assistance.
- **5.1.3.** Incentives for Quality Certification (ISO-9000, ISO-14000 etc) are also being given by Government of India. State Government will promote and facilitate the unit getting such benefits on priority basis.

5.2. Procedure

Application in **Form -1 along with Form-C** has to be submitted with all the enclosures to respective MD, IADA's/GM, DIC along with the prescribed documents.

Respective MD, IADA's /GM, DIC will scrutinize the application, received by them as per check list and, after site inspection of the unit, will forward the same to Directorate of Industry, Jharkhand, Ranchi within 3 weeks of receipt of application.

6. Patent registration

6.1. Eligibility

- **6.1.1.** Maximum Rs.1 lakh may be given towards the cost incurred in filing of Patent/Attorney fees/Patent tracking etc.
- **6.1.2.** On acceptance of patent, a maximum of Rs.2 lakh per patent, which will be inclusive of amount in Sl.1 above, will be reimbursed.

6.2. Procedure

Application in **Form -1 along with Form-D** has to be submitted with all the enclosures to respective MD, IADA's/GM, DIC along with the prescribed documents.

Respective MD, IADA's /GM, DIC will scrutinize the application, received by them as per check list and, after site inspection of the unit, will forward the same to Directorate of Industry, Jharkhand, Ranchi within 3 weeks of receipt of application.

7. Incentive for VAT

7.1. Eligibility Criteria

7.1.1. Industry wise admissibility of VAT incentive is indicated below:

7.2. Procedure

- **7.2.1** Request for issue of VAT Pass Book is to be made by the unit to respective MD, IADA's /GM, DIC.
- **7.2.2**. Within seven days of the request of the unit MD, IADA's /GM, DIC will issue a Pass Book to the applicant unit for certification of the tax payment by respective Circles of Commercial Taxes Department.

7.2.3. Application in **Form-1 along with Form-E** has to be submitted with all the enclosures to respective MD, IADA's/GM, DIC along with the prescribed documents.

Respective MD, IADA's /GM, DIC will scrutinize the application, received by them as per check list and, after site inspection of the unit, will forward the same to Directorate of Industry, Jharkhand, Ranchi within 3 weeks of receipt of application.

8. Overall Ceiling

- **8.1.** Subsidies to Industries under **Stamp duty & Registration Fee** (as per clause 32.2 of JIP-2012), **VAT Incentives and CPIS**, all added together, will not be more than total Fixed Capital Investment made by the company in the project. However, incentives for patent /quality certification and special incentives for SC / ST / women/ PH will not form part of this.
- 9. All the applications for incentive payment are to be made in duplicate within 12 (twelve) months of date of production or within 6 (six) months of notification of these rules. One copy of the application submitted will be retained by respective MD, IADA's/GM, DIC and another copy to be forwarded to the Directorate of Industry.

Example:

Let us assume that the DOP of a particular unit has been fixed as 5th March, 2014 and the notification of fiscal rules, is done on 15th September, 2014, then the application of unit claiming incentive will he entertained till 14th March, 2015 (i.e. within 6 months of notification of fiscal rules). Thus the last date of submission of application will be 14th March, 2015.

10. Disposal of applications

All applications received for incentives under JIP-2012 shall be placed before the committee mentioned below depending on the category of Industries.

- (a) Applications of Micro, Small, Medium & Large units for incentives under JIP-2012 under this rule shall be placed before the committee headed by Director of Industries and will consist of the following members:
 - i. Director of Industries

The above Committee headed by Director of Industries shall examine all the applications received and give its recommendations. After recommendation of the committee, decision about rejection/sanction of incentives shall be communicated to concerned units by Director of Industries.

If any unit is aggrieved of the decision taken by the committee, the unit may file an appeal before Principal Secretary/Secretary, Industries who, after hearing, may reject or revert back to the committee for reconsideration.

(b) Applications of Mega units, as defined in JIP-2012 for incentives under JIP-2012 under this rule, shall be placed before the committee headed by the Chief Secretary, Govt. of Jharkhand and will consist of the following members:

The above Committee headed by the Chief Secretary, Government. of Jharkhand shall examine all applications received and give its recommendations to Government. The recommendation shall be put up before the Government for approval. After approval of the Government, decision about rejection/sanction of incentives shall be communicated to concerned units by Director of Industries.

11. If the amount of incentives recommended by the committee head by Director of Industries exceeds Rs. 50.00 lakh, the disbursement of the amount will be done after the approval of the Government.
