**ORDER**

Subject: Scale-up and expansion of Pradhan Mantri Urja Suraksha evam Utthaan Mahabhiyaan (PM-KUSUM) Scheme

In continuation to Order of even number dated 08 March 2019 regarding administrative approval of Pradhan Mantri Urja Suraksha evam Utthaan Mahabhiyaan (PM-KUSUM) Scheme, sanction of President is hereby accorded for scale-up and expansion of PM-KUSUM Scheme to achieve enhanced solar capacity of 30.8 GW by 2022 with revised central financial support of Rs. 34,035 Cr. The revised targets under the three components of the Scheme are as follows:

- (i) Component-A: 10,000 MW of decentralized ground mounted grid-connected solar power plants of individual plant size up to 2 MW
- (ii) Component-B: Installation of 20 lakh standalone solar powered agricultural pumps of individual capacity up to 7.5 HP
- (iii) Component-C: Solarization of 15 lakh grid-connected agricultural pumps of individual pump capacity up to 7.5 HP including through feeder level solarisation.
