## Where can I view the amendments on the GST Portal?

To view the amendments on the GST Portal, perform the following steps:

You can view the amendments without login and after logging to the GST Portal.

1. Access the [www.gst.gov.in](http://www.gst.gov.in) URL. The GST Home page is displayed.

In case of pre-login:

- Click the **Services > Notifications & Circulars > Amendments** command.

In case of post-login:

- Login to the GST Portal with valid credentials.
- Click the **Services > Notifications & Circulars > Amendments** command.

In case of Center:

2. Click the **Center** tab to view amendments related to the Center.
3. From the **Choose the Year** drop down list, select the year for which you want to view amendments.
4. In the **Act Type** drop-down list, select the type of Act.
5. In the **Amendment No.** enter the amendment number that you want to search.
6. In the **Subject** field, enter the subject of the amendment you want to search.


In case of pre-login:

In the Type the characters you see in the image below field, enter the captcha text.




7. Click the **SEARCH** button.
