How can I search the details of a taxpayer registered under GST?

To search the details of a taxpayer registered under GST, perform following steps:

Note: The Search Taxpayer functionality allows you to view the profile of any other registered taxpayer at the GST Portal on entering the GSTIN/UIN. You can search the details of a taxpayer without login and also after logging into the GST Portal. You can view details of a taxpayer like GSTIN/UIN, Legal Name of Business, Trade Name, Effective date of registration, Constitution of Business, Principal Place of Business, Details of Return Filed etc. without login into the GST Portal. Once you login to the GST Portal, you can view additional details like Name(s) of the Proprietor/Director(s)/Promoter(s), E-way Bill History, Annual Aggregate Turnover, % of Tax Payment in Cash etc. of a taxpayer.
