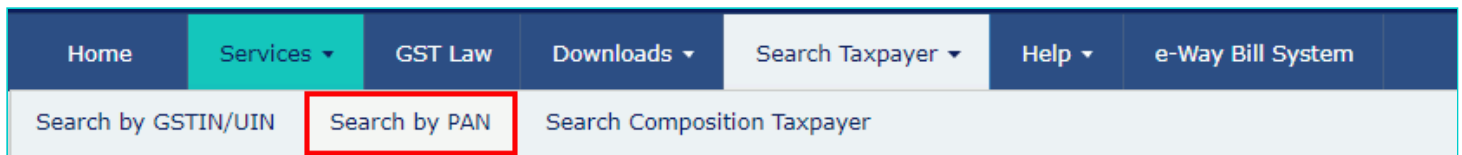
How can I search the details of a taxpayer using PAN on the GST Portal?

You can search the details of a taxpayer without login and after logging into the GST Portal. To view the details of a taxpayer using PAN on the GST Portal, perform following steps:

1. Access the www.gst.gov.in URL. The GST Home page is displayed.

2 (a). In case of pre-login


2.1 Click the **Search Taxpayer > Search by PAN** menu available at the GST Portal homepage.



2.2. In the **Permanent Account Number (PAN)** field, enter the PAN of the taxpayer whose details has to be searched.

2.3. In the **Type the characters you see in the image below** field, enter the **captcha** text.

2.4. Click the **SEARCH** button.


