As a new taxpayer, to login first time to the GST Portal with GSTIN and password, you need to perform the following steps:

- 1. Access the URL https://www.gst.gov.in/. The GST Home page is displayed.
- 2. Click the Login link given in top right-hand corner of the GST Home page.



3. The Login page is displayed. Click the here link in the instruction at the bottom of the page that says "First time login: If you are logging in for the first time, click here to login".
