1. How can I as a GST Practitioner perform functions on a taxpayer's behalf on the GST Portal?

To perform functions on a taxpayer's behalf as a GST Practitioner on the GST Portal, perform following steps:

1. As a GST Practitioner, login to the GST Portal with your Username and Password.

2.1. Once the GST Practitioner's dashboard is displayed, click the LIST OF TAXPAYERS button.
