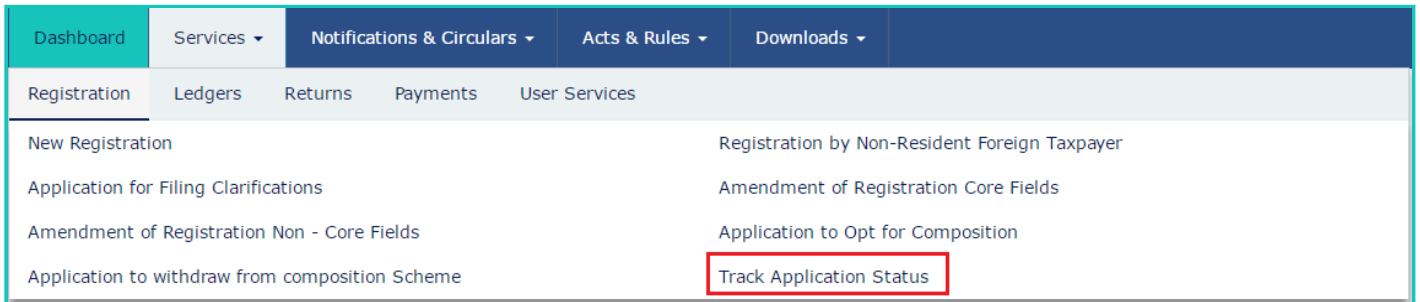


Manual > Track Application Status > Post Login

I am a taxpayer. How can I track status of my application that I have submitted after logging to the GST Portal?

To view status of your registration application after logging to the GST Portal, perform the following steps:

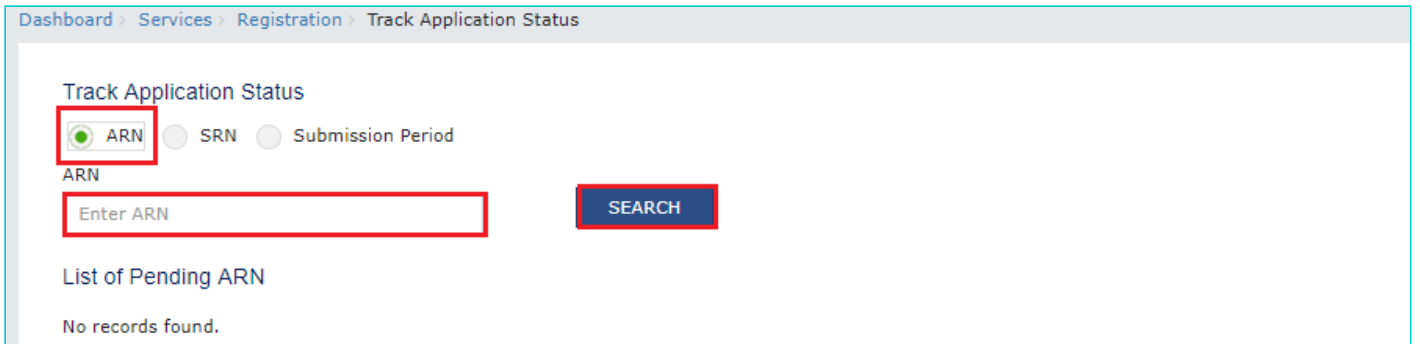
1. Access the <https://www.gst.gov.in/> URL. The GST Home page is displayed.
2. Login to the GST Portal with valid credentials.
3. Click the **Services > Registration > Track Application Status** command.



In Case of ARN:

On submission of the application on the GST Portal, you will be given an **Application Reference Number (ARN)**.

- a) Select the **ARN** radio button.
- b) In the **ARN** field, enter the ARN received on your e-mail address when you submitted the registration application.
- c) Click the **SEARCH** button.



- d) The Application status is displayed.

In Case of SRN:

- Click the **SEARCH** button.
