ORDER

Subject: Amendment in the Operational Guidelines for implementation of National Livestock Mission {Revised as on 27th April 2016}


In pursuance of the approval granted by the Union Minister Fisheries Animal Husbandry and Dairying to the recommendations of Executive Committee in its meeting held on 27th August 2020, the Government of India hereby makes the following amendments in the Operational Guidelines of National Livestock Mission issued on 27th April 2016 in the public interest

1. Under EDEG- Poultry Venture Capital Fund, all the 13 activities shall be treated as deleted and new component namely "Establishment of Backyard Poultry" shall be included for which subsidy will be 25% (upto Rs. 12.00 lakh) for establishment of composite Backyard Poultry Unit having Parent Farm, Hatchery Unit and Mother Unit to rear the chicks produced out of the Hatchery. Detailed components to be available for loan is attached at **Annexure I.**
2. Under sub-component IDSRR-EDEG, in addition to existing activities a new component namely "Breeding Farms with 500 ewe/does and 25 rams/bucks with the provision of necessary infrastructure shall be included, for which subsidy of 25 % upto Rs. 21.50 lakh will be eligible. Detailed components to be available for loan is attached at **Annexure II.**
3. In the EDEG- Pig Development, in addition to existing activities, new activity namely "Pig breeding Farm for Production of High Genetic Merit Germplasm with 100 sows and 10 boars including all infrastructure shall be included for which a subsidy of 25 %, upto Rs. 12.57 lakh limit will be eligible. Detailed components to be available for loan is attached at **Annexure III.**
4. Under Sub-mission on Feed and Fodder Development, the assistance for Distribution of Power Driven Chaff Cutter shall be revised to the tune of Rs. 20,000/- for one unit instead of different upper ceilings based on Horse Power and livestock holding.
5. The rate of assistance will be read as double from the current rate of assistance by the Central Government for Establishment of High Capacity Fodder Block Making Unit and hay making machine / reapers / forage harvesters wherever applicable.

6. The rate of central assistance under 'Establishment of Silage Making units shall be double and also include new activity, Establishment of Silage Making unit of 2000 to 2400 MT capacity, for which 60% central assistance will be provided, upto a limit of Rs. 30.00 lakhs. Fodder Cutter and Trolley loader may also be included as a new component under this category.

7. The activities namely "Establishment of rural slaughter houses", shall be treated as deleted.

8. As regards to Establishment of Bypass Protein making units and Establishment of Area Specific Mineral Mixture / Feed Pelleting / Feed manufacturing unit, this component will be continued only for Dairy Cooperatives.
