OFFICE MEMORANDUM

Chapter- VII of the Indian Partnership Act, 1932, provides for registration of partnership firms and details procedure is laid down vide Section 56-71 of the Act for issue of firm registration and other related matterss including appointment of Registrar of firms by State Governments.

- 2. Accordingly, in exercise of power confirmed under Section 57 of the Indian Partnership Act, 1932, the Government of Tripura has empowered the Department of Industries & Commerce; vide the Rules of Executive Business of the Government of the State of Tripura, 1972 for dealing with all issues under Section 59 of the Indian Partnership Act, 1932 related to Firm Registration.
- 3. The detail procedure for issue of firm registration will be as follows:
 - i. Partnership firms will be required to apply to Director of Industries & Commerce. Government of Tripura for firm registration as per prescribed format at Annexure-I.
 - ii. Fee of Rs. 3 (three) for registration and fee of Rs. 2 (two) for inspection, total Rs. 5 (five) only in form of a demand draft drawn in favour of "Director, Directorate of Industries & Commerce, Government of Tripura" from any nationalized bank shall be deposited along with the application form.
 - iii. The applicant firm will be required to submit a self certified copy of the registered partnership deed and photocopies of other necessary documents as per Annexure-II to establish identity of the partners, address of the principal place of business and licenses (if applicable).
 - iv. On submission of the application, a letter will be issued by competent authority with 7 (seven) working days intimating about any modification/correction required in the application form or document to be submitted in conformity with the Annexure-II.
 - v. The necessary modification/correction shall be complied with by the applicant firm within next 7 (seven) days failing which the application may be summarily rejected.
 - vi. All the original documents shall be produced on a scheduled date for inspection. The date will be intimated by an Officer authorized by Director, Industries & Commerce on his behalf on submission of complete correct application form with all the pre-requisite documents.
 - vii. On submission of complete correct application form with all the pre-requisite documents, firm registration will be issued within 15 (fifteen) working days reckoned from the date of inspection of the documents.
 - viii. Any application for alteration of firm name, principal place of business, opening of branches, recording of change in and dissolution of a firm will be recorded in the Register of Firms by an entry by the Registrar following the provisions of the Act.

(Note: All the documents in original shall be produced on the date of inspection.)
