









Sector Snapshot

AVGC is a sunrise sector in India, and is expected to grow substantially



India accounts for more than 6% of global production in animation, VFX and post production processing

Employment to increase almost 4 times in next 5 years from ~10,000 currently

Indian animation, VFX and post production market has grown 20% in 2 years from INR 4,200 crore in (USD 700 mn) in 2013 to INR 5,040 (USD 840 mn) in 2015

Karnataka has the strongest presence of AVGC industry among all Indian States











Presence of Major Suppliers







- Technicolor, MPC, DreamWorks have already expressed their interest to partner






